

1. Background

- 1.1 Aston Clinton Parish Council (ACPC) raised concerns relating to parked vehicles affecting visibility/vision splays in the vicinity of the Shell Garage on Aylesbury Road, Aston Clinton. As a result of these concerns, an informal consultation was undertaken, and proposals have been drawn up to introduce double yellow lines on both Aylesbury Road and at a number of nearby junctions to prevent unsafe parking in line with the Highway Code (Rule 243).
- 1.2 An opportunity has arisen to advertise the proposed parking controls on Aylesbury Road, Aston Clinton and the adjacent junctions by combining it with another scheme which Buckinghamshire Council are undertaking. Delivering these schemes together will save significant costs in the advertising and making of the legal Traffic Regulation Order (TRO).

1.3 ACPC have secured the full funding for the Statutory Consultation and implementation via the Wendover and Villages Community Board.

2. Authority to take this decision

3. Other options available, and their pros and cons

All other options were considered at the Informal Consultation stage; however, they were discounted as they would not resolve the parking issue. All other options which were considered would also involve a Statutory Consultation process. If we do not proceed with the proposals, it could result in the continuation of potentially unsafe parking which is currently affecting driver visibility.

4. Conflicts of interest

5. Feedback from Consultation

5.1 An informal consultation regarding the possibility of introducing new parking controls was led by a working group in September 2021. As a result of the Informal Consultation responses, a

decision was made by the working group to introduce 'no waiting at any time' (double yellow line) controls on Aylesbury Road, Weston Road, Hyde Street and London Road. The proposals that are proposed for the Statutory Consultation are outlined in detail in Appendix A.

5.2 The relevant Members were consulted as part of the Informal Consultation and wish for the proposals to proceed to Statutory Consultation.

7. Next Steps and Review

The Statutory Consultation is anticipated to go live mid-July 2023 and will continue for approximately six weeks. Feedback will be collated following statutory consultation and analysed by Buckinghamshire's Highway Alliance. The results and a recommendation will be submitted to ACPC and Members. Subject to the feedback received, a Key Decision Report (KDR) may be required to determine the next steps.
