Such an interest can arise directly through the legal ownership of an asset or indirectly where you are the beneficiary of a trust. “body in which the relevant person has a beneficial interest” means a firm in which the relevant person is a partner or a body corporate of which the relevant person is a director, or in the securities of which the relevant person has a beneficial interest;

“director” includes a member of the committee of management of an industrial and provident society;



