Hi Anne-Marie,

Thank you for your email. With regard to the actions I have added updates below:

- A copy of the July CAR – this has not yet been finalised but I understand a CAR form for 3 March and 2 CAR forms for 15 May were sent to you on 26 August.
- Monitoring data from the May incident – details about the water quality probes and accessing the data should also have been sent to you on 26 August (I've added the text and link below).
- Any updates on referring incidents to the Enforcement Governance Group – the incidents are being discussed at our September Enforcement Governance Group.

Water Quality probes. For the duration of a number of months, the Environment Agency had two Water Quality probes measuring different water quality parameters in the River Thames. The first probe was located approximately 200 metres downstream of the Little Marlow Sewage Treatment Works outfalls, the second probe was located approximately 1200 metres downstream. Please find a link to the data for both probes below. Please note the data is no longer live, as the probes have now been removed. However you can scroll back and view the data for the parameters selected.

We have also attached a document explaining the different water quality parameters that are measured, while also describing the patterns and levels we expect to see. Additionally, it also explains what we are monitoring for and why we look at each parameter. It also answers some frequently asked questions about water-quality monitoring using multi-parameter probes. Please note however, the data provided is raw data collected by continuous (water-quality) measuring equipment deployed in the field. This data haven't been processed in any way.
