"member" includes a co-opted member;

"sccurities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

the "nominal value" of shares is usually the face value on the share certificate when issued (in contrast to the "market value" which can often be considerably more but may be less)
