STATEMENT OF REASONS

VARIOUS ROADS IN HADDENHAM

20, 30 & 40 MPH SPEED LIMITS

Under Section 1(1) of the **Road Traffic Regulation** Act 1984 the specified reasons for considering this change are:-

- 1. For avoiding danger to persons or other traffic using the road or for preventing the likelihood of such danger arising.
- 2. For preserving or improving the amenities of the area through which the road runs.

Rudd's Lane	For its entire length
Willow Rise	For its entire length
Windmill Road	For its entire length

2. To introduce a 30mph speed limit on the following length of road:

C66 Stanbridge Road	From a point approximately 95 metres south of its junction	
	with Willis Road, for a distance approximately 317 metres	
	in a southern direction	

3. To introduce a 40mph speed limit on the following length of road:

A418 Scotsgrove Hill /	From a point 310 metres southwest of its junction with C70
Aylesbury Road,	Thame Road, to a point 138.5 metres north of that junction.
C70 Thame Road	From its junction with A418 Scotsgrove Hill / Aylesbury
	Road, to a point 374 metres northeast of that junction.
Mill Lane	For its entire length

BUCKINGHAMSHIRE COUNTY COUNCIL (hereinafter referred to as "the Council") in exercise of the powers under Sections 84(1) (a) and (2) of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and having regard to Section 122 of the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

- 1. No person shall drive any motor vehicle at a speed exceeding those specified in (Schedule A-20 miles per hour, Schedule B-30 miles per hour & Schedule C-40 miles per hour) on the lengths of road specified below to this Order and shown for the purposes of identification on the plans attached this Order.
- 2. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
- From the date that this Order takes effect, the following Order shall be amended as follows:
 "The Buckinghamshire County Council (Various Roads, Various Parishes in Area 7)
 (30mph Speed Limit) Order 2007"

To revoke: Schedule 1

Name of Road and Parish	Length of Road Affected

4. This Order may be cited as "The Buckinghamshire County Council (Various Roads in Haddenham) (20, 30 & 40 mph Speed Limits) Order 20**" and shall come into operation on ** 20**.
